Founded over 40 years ago in response to the challenges many disaster organizations experienced following Hurricane Camille, a category 5 storm that hit the Gulf Coast in 1969. As an outcome, National VOAD was formed with a Mission to be the forum where organizations share knowledge and resources throughout the disaster cycle—preparation, response and recovery—to help disaster survivors and their communities.

## Missouri Emergency Amateur Radio Communications Committee

#### Mission:

Develop and support collaboration and capacity building among all voluntary organizations that provide emergency radio related communications services in disaster.

Missouri VOAD Task Force for COADs and LTRCs a.k.a. Joint VOAD and Citizen Corps Committee (VO/CCC)

#### Mission:

This joint committee is responsible for activities that represent the whole community approach in support of the goals and objectives of federal, state and local COAD partnerships. This approach to develop and sustain emergency human services capacity has been tested time and again and has become an integral part of emergency management doctrine in the State of Missouri

## Access and Functional Needs Committee

#### Mission

The Access and Functional Needs
Committee will engage the whole
community, including vulnerable
populations, to plan for access and
functional needs support services so
that everyone in Missouri will be
afforded the greatest degree of
independence and self-determination
possible in all phases of emergency
management.

- \* Develop collaborative systems and resources for contacting survivors in their disaster affected residences and assessing their disaster related needs; and coordinate the services and collaborative efforts of organizations that provide in-home help to disaster survivors so that such services are effective, coordinated, timely and efficient.
- \* Develop and implement training and outreach to inform and educate responding partners about individuals with and without disabilities with access and functional needs and the support mechanisms available to support these needs.
- \* Develop and implement a system to support the provision of access and functional needs at congregate emergency shelters and other congregate emergency response venues during disasters.
- \* Encourage the full integration of access and functional needs support services into the emergency operations plans of all Missouri jurisdictions.

#### Citizen Corps Committee

#### Mission:

The Citizen Corps Committee will support local Citizen Corps and community preparedness organizations; will strive to foster collaboration; will offer Councils a wide variety of programs and fund sources; and allow them to share innovative practices and approaches.

- \* Identify needs and develop a statewide strategy for increasing first responder and volunteer collaboration.
- Developing statewide marketing strategies.
- \* Matching training needs with other major state training initiatives.
- \* Ensuring that citizen Corps and community preparedness organizations receive consideration for any relevant grant funding administered by the state.
- Supporting Citizen Corps by developing relevant state policies and practices.

#### Emotional and Spiritual Care Committee

#### Mission:

The Emotional and spiritual Care Committee's mission is to develop strategies and networks to foster emotional and spiritual care to people affected by disaster.

- \* Offer training for clergy and emotional care providers in communities.
- \* Coordinate the orderly application of Emotional and Spiritual Care resources to disaster affected communities.
- \* Develop systems that allow resources to be coordinated in a disaster affected community.
- \* Implement the National VOAD doctrine for emotional and spiritual care and promote the points of consensus.

#### Mission

The Disaster Case Management Committee will enhance partnerships to promote recovery among disaster affected households by utilizing a whole community approach.

- Advocate for appropriate legislation to overcome systemic barriers to disaster case management
