- ** New Public Meeting Requirement After RMP Reportable Accidents with Off-site Impacts
 Per 40 C.F.R. § 68.210(b), RMP facilities that have a reportable accident with off-site impacts
 that occurs after March 15, 2021 have 90 days to hold a public meeting to provide information
 about the release and changes made to prevent future releases. Information to be discussed at
 these meetings include:
 - Date, time, duration, chemical(s) released, estimated quantity, process NAICS code, type of release event and its source, and weather conditions;
 - On and off-site impacts and whether off-site responders were notified;
 - Initiating event and contributing factors; and
 - Operational or process changes that resulted from investigation of the release.

These meetings may be stand alone or combined with other public meetings, such as LEPC meetings, as long as the facility lets the public know that the release will be discussed as part of the meeting. EPA Headquarters is working on guidance about the new requirement, which will be posted at www.epa.gov/rmp when it is available. Per the past 5 years of RMP data, Region 7 states average one accident per state per year that would trigger this new public meeting requirement.

EPCRA Trade Secrecy Claims Amendment

On July 24, 2020, EPA published a technical amendment to remove the outdated substantiation form for trade secrecy claims from the Code of Federal Regulations. The most current substantiation form is posted on www.epa.gov/epcra/epcra-trade-secret-forms-and-instructions. The Agency is also including clarification within a note in 40 CFR 355.41 to make regulated entities aware that SERCs and/or LEPCs may have a specific format for the follow-up report of the emergency release notification information. Throughout EPA's 50-year history, emergency preparedness and response operations have changed drastically. In some instances, this has resulted from major federal policy changes spurred by significant events. In others, technology like bag phones has given way to iPhones. Today, Region 7 responds to about 40 emergency incidents per year. Responses range from pipeline leaks and floods to train derailments, tire fires, oil and mercury spills, and more.



Type and amount of product spilled:	Road Diesel Fuel Approximately 2,000 gallons
Cause of spill:	Leak from the above-ground storage tank (AST) system
Key operational activities:	Contain leak with interceptor trench, testing AST system for leak cause, pumping out liquids in AST containment, setting oil sorbent boom dams down gradient, exploratory soil boring for source and path of release, excavation of contaminated soil.
Agencies involved:	City mayor, DNR EER, DOA, responsible party contractor, PSTIF
Major lessons learned:	Become aware of incident earlier for less impact

California Shingle Fire

Date:	3/9/21, discovery date
Type and amount of product spilled:	Asphalt shingle and building material dump and fire
Cause of spill:	Materials dumped on private property for some time involved in a fire caused by a nearby unattended trash fire

Key operational activities:	Inspection and evaluation of location hazards, determination of smoke plume affects, determination of water quality affects, issues with working with responsible party, hiring state contractor to extinguish fire, passing information on to other DNR program enforcement parties
Agencies involved:	DNR regional and central offices, DNR EER, state contractor, local fire and sheriff's department
Lessons learned:	Obtaining cooperation with responsible party, adjusting the Hazardous Substance Emergency Declaration/Order for this incident

EPCRA/Tier II Section, Lana Nelson and Karen Eagleson: Tier II system is coming along with fewer system problems. We are still in the final stages of the Tier II season. We extended the Tier II reporting season until June 30th due to ironing out the bugs in the Tier II reporting system and to make sure everyone completes their reporting. It is estimated that approximately 500 to 1,000 facilities still need to file or have begun the process, but need to finish.

LEPC/Planning Section, Sara Allen: The LEPC/Planning section has been in full swing since January with compliance visits, CEPF applications and working with LEPC/LEPDs to get their operations in compliance with Federal and State Statutes, Regulations and MERC Rules.

Planning has been paused for the most part at this time. Due to the resignation of Steven Shaw, we are down to one planner in the State and will need to look at contracting at least three more by the end of the calendar year. Mr. Shaw resigned as a planner due to health reasons stemming from a motorcycle accident.

Old Business

New Tier II Database

The deadline for Tier II submission has been extended to June 30, 2021 due to issues with the new Tier II system. There are 500-1,000 facilities who haven't filed yet. Brian Allen asked how many Tier II reports are generally filed each year. Mike stated the annual tally is 9,000 to 10,000 total.

Mike and Bill Brinton will be visiting the ammunition plant in Gentry County as they have not filed in many years. Mike is wanting to visit those facilities who do not file and explain the necessity for Tier II reporting. Another issue is the chemical Plant, Manor Chemical, in St. Louis. The EPA is handling the issue of the explosion and fire at Manor Chemical.

The MERC Training and Exercise unit at the end of September will see what is left of training requests and schedule some more classes. MERC has received accolades from PHMSA. They use our training as a model in other states. Bill Brinton and Alan Cortvrient spoke highly of MERC instructors; mostly notably Mike Schultz put together Hazmat Sizeup training. MERC training instructors are top notch and deserve many kudos.

LEPC/D Issues Update

Cory Jorgensen questioned how many LEPCs have one paid member of their LEPC. Mike noted that 88% of LEPC/Ds had major spending problems. Some were minor; some were major. In the past three years, \$555,000 was misspent by LEPC/Ds.

Chris Berndt stated he is on the LEPC and is an Emergency Manager. He said that if we removed the EMD as Chairman or Vice Chairman, it won't prevent money from being misspent. A discussion ensued about having a process where all LEPC/Ds will go through for major equipment by having a proposal being approved by their LEPC/D and then sent to MERC for approval.

There was discussion about revisiting reinstating EMDS as Chair/Vice Chair at a later date. It was noted that some LEPCs have replaced the LEPC Chair with their Presiding Commissioner. Chris Berndt noted a need to educate everyone with LEPC 101.

Bill Brinton is on the Emergency Management Commission. In small counties there is a need for a person to keep them organized. Bill said they had a meeting in Region H and discussed EMDs being taken off LEPC/Ds as Chair/Vice Chair. Brian Allen asked if moving forward, are we able to identify counties that have issues and get a report for the commission. Brian requested the MERC to report at the next meeting summarizing how their efforts to meet with counties and educate them on LEPC 101/rules are going and the feedback MERC is getting. Mike said MERC will begin to report out on every LEPC 101, etc. We will leave it as is for the moment.

Chris Berndt asked for a point of clarification if city EMDs can be the LEPC/D Chair/Vice Chair. According to Mike, DPS legal said we need to exclude all EMDs – county and city. An extensive discussion ensued with SEMA Director Remillard stating the whole purposed with this situation is education. This will take time. There have been many educational opportunities and this will continue. Mike noted this will likely be a three-year education program. He also stated there was an exhaustive process with DPS legal to make sure the intent of the law is followed. Director Remillard assured the commission the executive level in Missouri to make sure MERC followed the intent of the law.

Cory Jorgenson asked MERC watch our language in the minutes, etc. to make sure the language is positive. Mike stated MERC is trying to be positive about language sent out. He has everyone in the MERC office read important emails for positive language.

New Business

HazMat Regional Response Teams

MERC used to support HazMat Response Teams. We have some great ones and some that don't have capabilities. MERC would like to help support them with physicals, etc. We are not setting levels. Our business is to support the teams. MERC will survey teams out there for the needs, strengths, etc. and how can the MERC support the teams.

MERC wants to have the Fire Chiefs Association involved. Also involved the Regional Fire Mutual Aid folks. Add Chris Berndt, the Kansas City Fire Chief and the St. Louis Fire Chief to the HazMat Team Advisory Committee.

Brian Allen made a motion to go forward with the process. Cory Jorgensen seconded. The motion carried after discussion of the following items.

Chief Berndt stated HazMat teams have lost focus after 9/11 and dried up. Bill Brinton noted we are talking about \$200,000 or \$250,000. Mike Harris said it will be funded partially by HMEP and partially CEPF.

LEPC/Ds

There was a discussion on statutes. Could MERC establish LEPDs for small counties that can't form a LEPC? Mike Harris needs guidance from the commission on what to do with it. Brian Allen noted it is a good idea to suggest it and make it all voluntary.

Chris Berndt asked if the money goes to the county. The money goes to the county and the county treasurer is to transfer it to the LEPD account. The LEPD is supposed to make sure it's fair for each county.

Cory Jorgensen made a motion to survey the counties and move forward with forming LEPDs. Brian Allen seconded. Motion carried.

FY23 Budget and Staffing Requirements

MERC has a huge roadblock as we don't have personnel to do what we need to do per Mike Harris. MERC needs two full time employees (FTE) and would like another FTE.

First, the LEPC/Planning Coordinator is Sara and is a part-time contractor. Mike would like to move her into that position as a FTE.

Second, the Assistant Training Coordinator is H. Whitt Kellough. He is also a part-time contractor. Mike would like to transition Whitt to the EPCRS/TIER II and Exercises so that he may work on investigations.

Third, Mike wants another position which would make the Training/Exercise Coordinator (who is Lisa Jobe, a part-time contractor) a FTE who would also serve as the Deputy MERC Director. This position could be in charge and run operations when the Director is out of the office.

Mike also asked that Lana Nelson be promote to the position she has been doing for a years. This position is a G-9 but she is currently paid as a G-8. She hasn't complained with it but she has been doing the job for over a year.

Mike is looking for approval from the Commission to approve full time positions. We charge northing to the State General Revenue.

Mike is requesting the appropriation for E&E HazMat Team Response be \$250,000. Brian Allen wants to make sure these requests will not harm LEPCs. Mike needs a motion to support the changes for MERC to work with SEMA to increase personnel in MERC.

Chris Berndt motion to support the changes for MERC to work with SEMA to increase personnel. Cory Jorgensen seconded. Motion carried.

MERC Instructors Request

MERC instructors made a request to attend the International HazMat Response Conference held virtually. Registration is \$99 per person. The instructors are asking if the amount of time attending the conference will be compensated. The request was made for a motion to pay the \$99 registration and time while on call.
