Reports:

EPA is proposing to amend the Accidental Release Prevention Requirements of Risk Management Programs under the CAA Section 112(r)(7). The proposed revisions aim to modernize its chemical safety and security regulations, guidance, and policies are required under Executive Order (EO) 13650. EO 13650 directs the federal government to carry out a number of tasks intended to prevent chemical accidents, such as the explosion in West, Texas on April 17, 2013.

The proposed revisions include several changes to the accident prevention program requirements, including:

- An additional requirement for the process hazard analysis required for Program 3 processes,
- Enhancements to the emergency preparedness requirements,
- Increased public availability of chemical hazard information, and
- Several other changes to certain regulatory definitions and data elements submitted in the RMPs.

To ensure that this nation is better prepared for environmental emergencies, EPA is working with other federal partners to prevent accidents as well as to maintain superior response capabilities. One of our roles is to provide information about response efforts, regulations, tools, and research that will help the regulated community, government entities, and concerned citizens prevent, prepare for, and respond to emergencies. DNR-Section staff continues to engage and support local planning efforts through regular attendance at LEPC/LEPD and RHSOC meetings, either as standing committee members or in an Ex-Officio capacity. Staff also attended the EPA EPCRA and CRIB meeting at the EPA Region 7 office on March 9, 2016 and participates in other meetings such as Region 7 RRT and associated sub-area committee meetings.

For FY16 (July 1, 2015-March 15, 2016) 1003 incidents have been entered (290 meth-related; 713 non-meth) into the Missouri Environmental Emergency Response Tracking System (MEERTS) and State On-Scene Coordinators (SOSCs) have made 146 responses. SOSCs generally respond to between 20-25% of non-meth related incidents received on the spill line in any given year to ensure adequate and appropriate cleanups are undertaken. In addition to the incidents documented in MEERTS, staff have logged and managed 326 technical assistance inquiries into the spill line and logged participation at 242 outreach events for FY16 through March 15, 2016. The department is also implementing enhancements to web postings, including incident data, to better serve the public and stakeholders interested in that data.

Currently, the department is coordinating with other state and federal agencies on the topical issue of Avian Influenza. Outbreaks last year at two separate concentrated animal feeding operation facilities impacting turkeys were a concern and the possibility of another outbreak is being monitored because of the natural migration of waterfowl. Continued planning for Harmful Algal Bloom occurrences is continuing for this year's summer season.

The Department was actively engaged with requests for assistance from statewide flooding that began about December 26, 2015. Flooding impacted many citizens, business owners, property owners, and public areas. Regional offices actively assisted local officials concerning drinking water, waste water, solid waste, and hazardous waste issues. Dam Safety staff assisted local officials to assess multiple damaged impoundment dams deemed at risk. EER staff engaged the U.S. EPA, the U.S. Army Corps of Engineers, the Missouri National Guard, and the U.S. Coast Guard in emergency assistance and cleanup. EER SOSCs were engaged in the St. Louis area, supporting the U.S. EPA's FEMA-assigned missions to remove debris, orphaned containers, household hazardous waste, and e-waste.

Division of Fire Safety report was included in the packet.

DHSS reports the program inspected 8 Radiation shipments this past quarter

The program provided internal training for Rad Team volunteers in the areas of air, water, and vegetation sampling for nuclear power plants. In addition, personal protective equipment, source identification, and equipment use were practiced.

The program attended a RAC meeting, RRT meeting, several local meetings, and 3 Bridgeton Business Coordination meetings.

- -One displaced radiation device was investigated this past quarter.
- -One exercise was attended on December 10 for the Callaway Plant.

The HRAP is responsible for evaluating human exposure to hazardous substances in the environment and for making health-protective recommendations regarding actions needed. These evaluations are on-going and arise when environmental emergency responses take place involving the public.

EPCRA Specialist was given by Karen Eagleson. She reported that 9 letters have been mailed for non-compliance. The 12 final notices that had been mailed from last Commission meeting have all filed. The MERC has added 25facilities to the no reportable quantity list which brings the total to 1,571. After the archive, 497 facilities are being researched for letters to be mailed. Mailed our 487 Manual reports in December.

LEPC CEPF reviews completed were Dade, Cole and Saline counties.

Hazmat Planners reports were provided in the packet.

Training numbers were included in the packet.

MERC Directors Report was given by Dawn Warren. She advised of Dean Martins' resignation, stating that she would be stepping into the role to assist the MERC, until new Director is found. Director Walker spoke in regards to the hiring process.

A discussion ensued on the possibility of a more appropriate Flood Plain Management class being developed by DNR and Health that would be more assistive for Hazmat situations.

Old Business:

Tier II updates – Patricia Tye reported in 2015 there were 8,706 reports that were received and to date the MERC has received 7,972 for the 2016 year. While the numbers above show that we are below last year's totals, we are still processing and receiving Tier Two reports daily.

Optional Distribution continues to gain popularity with our filers, with approximately 2800 facilities selecting the option. I estimate that number to be closer to 3,000 by the time all the processing is complete.

Several of the counties have a small amount of storage space, and called to let us know they wish not to have the paper copies mailed to them. This year we will be emailing the Tier Twos to the LEPCs and Fire Departments with 5 or less reports. More than 5 will be sent on a flash drive. We will be starting that task once we have completed the processing of Tier Two reports. LEPC/LEPDs will continue to have access to the website. If user ID is needed, they can contact the MERC.

New Business:

Dawn W. addressed the upcoming HMEP grant application. Dawn stated that there are changes in the grant application. It appears that there will be a reduction in the funding amounts.

PHMSA will be here the first week of April for a technical assistance visit. Rather than approving the application now, we will wait until their visit, get their recommendations, and hold a conference call for the commission to review the grant application, and then approve it via conference call.

Bill H. voiced concern over the cost per student ratio. Dawn stated that PHMSA does comparisons to other like courses in the country. Dawn voiced concern over the pass/fail rate in the classes that are internal deliveries. We are seeing a fail rate of approximately 75% on the in jurisdiction deliveries of this class. She would like for us to look at that process to help those students be more successful.

Bill H. voiced concern over the Hazmat Tech class format. Discussion over modular set up. He suggested the Commission discuss the fail rate in internal deliveries.

Dawn suggested that these issues could be further reviewed by the Hazmat Committee.

Motion made by Bill H. to pass to Hazmat Training Committee, The review of the Awareness Class to establish guidelines for internal deliveries, as well as a Review of the Hazmat Tech class to modules. Second by Cory J. Motion carried.

LEPC membership approval requested for Barton, Carroll, Dade, Cedar, Cole, Douglas, Dallas, Shannon and Webster counties. Motion made by Cory J. Second by Lisa C. Motion carried.

A copy of the 2016 CEPF grant application was provided in the packet. Commission was requested to review application and approve for sending out to counties via email. Motion made by Bill H. Second by Brian M. Motion carried.
