On June 13, 2016 federal register 39104 FR 81 was published amending EPA's hazardous chemical reporting regulations at 40 CFR part 370 (EPCRA 311/312) to conform to the revisions of OSHA's HCS due its adoption of the GHS classification and labeling of chemicals. Facilities will be required to report the new information on their CY 2017 Tier II reports (due March 1, 2018). Though EPA will immediately begin work modifying Tier2 Submit and the associated forms, EPA is providing flexibility to allow states to modify their software by January 1, 2018 to accept the new information. ### DNR

The EER staff continues to engage and support local planning efforts through regular attendance at LEPC/LEPD and RHSOC meetings, either as standing committee members or in an Ex-Officio capacity. The EER staff also represents the Department at the Regional Response Team meeting, and participate in other meetings such as Region 7 EPCRA and associated sub-area committee meetings

The following efforts have been documented in the Missouri Environmental Emergency Response Tracking System (MEERTS) and other databases.

## FY18 (July):

136 incidents (43 meth-related; 93 non-meth) 26 responses (28%)Note: SOSCs generally respond to 20-25% of non-meth related incidents received on the spill line in any given year to ensure adequate and appropriate cleanups are undertaken 41 technical assistance inquiries into the spill line were managed by EER staff 8 outreach events were participated in by EER staff

FY17 (January 1, 2017-June 30, 2017)549 incidents (52 meth-related; 497 non-meth) 158 responses (31.7%)

Note: The department is continuing to experience a decrease in methamphetamine lab seizures in Missouri. 199 technical assistance inquiries into the spill line were managed by EER staff. 262 outreach events were participated in by EER staff

Modular Emergency Radiological Response Transportation Training (MERRTT) The Department, along with partners in the Departments of Public Safety and Health and Senior Services, continues to provide MERRTT to response agencies along Missouri's radiation transportation corridors. The EER staff continues to be engaged with planning additional classes.

Chemical Suicide Training the EER staff has been trained through an arrangement with the MERC to assist with training local officials concerning Chemical Suicide. Classes are scheduled through the SEMA training web site, and SOSC Roarke Holzschuh has delivered classes this year (May 13, Worth County and August 12, Grundy County). An event was held at the Region 7 LEPC/TERC Emergency Planning & Response Conference on July 20-22, 2017, in Overland Park, Kansas. EER staff is pursuing additional training opportunities for newer staff to expand our support of training local agencies.

Division of Fire Safety report was brought to meeting by Greg L., and passed out to the commission. University of Mo Fire & Rescue Training-\$8,750 (open menu for the following classes) Emergency Response to Ammonia Incidents, Hazardous Materials Awareness: Internet, Rail Safety for Emergency Responders, Responding to Utility Emergencies

Three Rivers Community College- \$72,238 in partnership with Local Emergency Training Specialists and Response Technologies Corp(Open menu for the following classes) Hazardous Materials Refresher, Hazardous Materials Technician Practical Skills Testing, Handling Propane Emergencies, Hazardous Materials Safety Officer, Hazardous Materials Field Sampling In-Service

Training numbers from DFS were presented in the report to the commission. There is a Standard change for 2018 Fire1 and 2. NFPA 1072 is already published. We will make that change beginning July 1, 2018. At that time, course delivery for hazmat will no longer be approved through fire 1 and 2 curriculum. If a department wants to deliver a course "in house" they may only use IFSTA or JB. As the MERC uses IFSTA, this should drive more classes through the MERC.

DHSS report was delivered by Keith Henke. They have been assisting with the rewrite of the State Emergency Operations plan, ESF 8 and ESF 10. Recently, they participated in 2 "Reception Care Center exercises. Both were federally evaluated by FEMA and received favorable evaluations.

They continue to inspect the high level radioactive shipments that traverse the state.

EPCRA Report from Karen Eagleson was included in the packet. I have been working with the Tier II's that came in during season that have incorrect inventory codes. In Jan – April 54 facilities to update their Tier II's April – July 48 updated Tier reports. I will continue to call the facilities to complete the updates as they come to my attention.

During May and June I assisted with marking Tier II's paid in the Lotus notes system. The archive list is complete for cross reference of Tier II's that are

needed for 2014 and 2015. I am also look at facilities that have not filed for 2016. Letter will start going out by end of April for facilities that may need to file. I have been working with several Counties to complete their previous years of

### **Old Business:**

Tier II updates were given by Patti Tye. Patti reported that Tier II reports received thus far are 8,245. This is down by 300 from last year, but they continue to come in daily.

Optional Distribution is complete. This year we had a total of 2,988 facilities that chose optional distribution. They have been processed and sent on flash drives to 598 fire departments across the state. Fire departments with less than 5 optional distribution filers were sent paper copies. LEPC/Ds have access to our system to view Tier II reports for their counties.

## **New Business:**

Lana Nelson gave the CEPF updates.

2016 CEPF applications, we have 8 counties that are pending for documentation and 30 counties have yet to apply for 2016 CEPF. I received phone calls last year from the LEPC's concerned about the amount of money their counties were to receive. To rectify this problem for 2017 CEPF money, I am mailing a letter to the LEPC's and the County Treasurer to ensure less confusion of the amount of money to individual counties.

For 2017 CEPF applications, there were 18 counties granted extensions.

There are 14 counties that are pending for more documentation.

There have been 37 counties that have been approved by the MERC Director.
