EPA Reorganization - Effective October 1, 2015, the Chemical Risk Information Branch (CRIB) is merging with the Storage Tanks & Oil Pollution (STOP) Branch to form a new Branch called Chemical Oil Release Prevention (CORP) Branch. Some of the CRIB personnel may be asked to take on new or different duties. We will inform you of any duty changes.

Clean Air Act (CAA) 112(r) - Risk Management Program New OSHA PSM Rule OSHA has recently changed the requirements within the Process Safety Management (PSM) Standard, which affects fertilizer retailers. It requires all fertilizer retailers to participate in the PSM program. This decision may affect the Risk Management Program by requiring all fertilizer retailers to report under Program 3, depending on what EPA Headquarters decides. Currently fertilizer dealers are in Program 2, unless they mix chemicals on-site, which places them in Program 3. OSHA is providing a webinar on September 29<sup>th</sup> to explain these changes which affect fertilizer retailers. Dept. of Natural Resources was read by Alan Cortvrient. Section staff continues to engage and support local planning efforts through regular attendance at LEPC/LEPD and RHSOC meetings, either as standing committee members or in an Ex-Officio capacity. Staff also participate at MOP3 and federal agency-led planning efforts, such as Region 7 RRT and associated sub-area committee meetings. The department participated in the St. Louis Metro Cross Jurisdictional PREP Exercise sponsored by Marathon Petroleum on August 24-26, 2015.

Section staff continues identifying and updating risks to public drinking water intakes related to potential threats of releases from nearby industry/commercial activities. This involves partnering with other state agencies for their assistance (DPS and MDC). This effort is related to the West Virginia incident to help ensure awareness, preparedness, and communication between water systems, industry, and local/state officials.

For FY15 (July 1, 2014 - June 30, 2015) 1,588 incidents were entered (537 meth-related; 1051 non-meth) into the Missouri Environmental Emergency Response Tracking System (MEERTS) and State On-Scene Coordinators (SOSCs) made 222 responses. For FY16 (July 1, 2015-September 15, 2015) 261 incidents have been entered (42 meth-related; 219 non-meth) into the Missouri Environmental Emergency Response Tracking System (MEERTS) and State On-Scene Coordinators (SOSCs) have made 44 responses. SOSCs generally respond to between 20-25% of non-meth related incidents received on the spill line in any given year to ensure adequate and appropriate cleanups are undertaken. In addition to the incidents documented in MEERTS, staff has logged and managed 609 technical assistance inquiries into the spill line and logged participation at 476 outreach events for FY15. Staff have logged and managed 99 technical assistance inquiries into the spill line and logged participation at 33 outreach events for FY16 so far.

Currently, the department is coordinating with other state and federal agencies on several topical issues including: Avian Influenza outbreaks earlier this year at two separate concentrated animal feeding operation facilities impacting turkeys, Ebola planning and preparedness, and crude by rail planning and preparedness.

The section is currently providing oversight to five higher profile incidents. The Missouri Better Bean facility in Bunceton had a fire at the facility on August 29, 2015 and lost glycerin water and sulfuric acid to a nearby stream. Two barges collided on the lower Mississippi River near Wolf Island with loss of approximately 125,000 gallons of a heavy oil. The USCG has the lead and the responsible party is recovering oil from the river bottom. A tractor-trailer accident near Joplin released a defoliant material that when exposed to air becomes an oxidizer. The soil along the right-of-way has experienced spot fires because of the diesel fuel involved. The cleanup is a slow and meticulous process. A spelunking group reported gasoline odors in Berome Cave in Perry County. SOSCs have investigated the situation and collected samples. The investigation is continuing. Continuing oversight is occurring at a release of gasoline contamination that is affecting businesses, residences, and sanitary sewer in the area of 31<sup>st</sup> Street and Cleveland Avenue in Kansas City.

DNR is planning and assisting with five pesticide collection events in 2015 through funds resulting from a federal settlement. Since June, three events have taken place. These events were at Mount Vernon on June 30 with 4000 pounds collected, Higginsville on July 18 with 1100 pounds collected, and Owensville on August 15 with 1795 pounds collected. DNR staff maintains a daily presence in St. Louis County to conduct continuous air monitoring, twice-daily screening checks, and sampling associated with the Bridgeton Landfill.

Fire Safety was not present but information was provided in the packet.

Dept. of Health and Senior Services – Cory explained that in the future Keith may have information for the commission but does not at this time

EPCRA Specialist was given by Karen Eagleson. She reported that 611 letters have been mailed for non-compliance, 200 second notices and 32 final notices have been mailed. The MERC has added 48 facilities to the no reportable quantity list which brings the total to 1,531.

Hazmat Planners the information from the southwest planner was provided in the packet.

Hazmat Trainer 1350 responders trained 2015 grant season (estimated to September 30<sup>th</sup>, 2015). This is Up from 1117 in 2014 grant season. A breakdown follows:
