
Elevation Certificate (EC) Basics Workshop is for Everyone!!

As part of the common interagency efforts, the State Risk Management Team and SEMA invite communities in Missouri to apply for **FREE** historic flooding signs. The signs will capture past events using a photo, historic high water marks, flood depths, loss of life, and historic flood damages that the community has experienced. Communities can apply for signs in as many locations as they want, while the project budget lasts. Some communities are even setting up a flood tour using the signs a guides. Offer ends **September 30, 2019**.


Data Visualization: Historical Flood Risk and Costs

Each year, more deaths occur due to flooding than from any other hazard. The Centers for Disease Control and Prevention report that over half of all flood-related drowning occur when a vehicle is driven into hazardous flood water. The next highest percentage of flood-related deaths is due to walking into or near flood waters. People underestimate the force and power of water. Many deaths occur in automobiles as they are swept downstream. Of those drownings, many are preventable, but too many people continue to drive around barriers warning that the road is flooded. A mere 6 inches of fast-moving flood water can knock over an adult. It takes just 12 inches of rushing water to carry away a small car, while 2 feet of rushing water can carry away most vehicles. It is NEVER safe to drive or walk into flood waters.

Congratulations to the City of Blue Springs! On October 1, 2018 the city entered the CRS program as a CRS Class 9!


